At this time the Mayor asked for a motion to go out of the regular order of business so that our CFO and Auditor can discuss the 2021 budget. The CFO stated that the State has not reviewed our budget yet. So all we can do tonight is open the meeting to the public.

Motion to go out of the regular order of business by Councilwoman Cheatham, seconded by Councilman Lorenzo and approved on verbal vote. None opposed.

Joe said as he was stating, the budget review has not been done by the State as of tonight. Since the public hearing was scheduled for tonight, we have to go through with that. When the State review is done at that time all we have to do is adopt. No other public hearing as it is being held tonight.

Mayor Holeman asked for a motion to open this portion of our meeting to the public for the hearing on the budget.

Motion made by Counilman Lorenzo, seconded by Councilwoman Cheatham and approved on verbal vote. None opposed.

Jim Janone - What is the percent going up in the budget? Joe said the actual budget has gone down. It is lower than last year. If you are asking what the tax rate is - it is $3\frac{1}{2}$ %. Is that by law? Yes, we passed an ordinance. Why did that go up to $3\frac{1}{2}$ %? Because revenues have been down. We lost money in interest, court, sewer and construction. The money that we are supposed to get from the State, will that help us? It depends on when we get it and how much we get. I can't anticipate that money in with this budget because we don't have it. We took a significant hit from all these items I mentioned.

Motion to close this portion of the meeting to the public by Councilman Lorenzo, seconded by Councilwoman Cheatham and approved on verbal vote. None opposed.

Motion to go back into the regular order of business by Councilwoman Cheatham, seconded by Councilman Lorenzo and approved on verbal vote. None opposed.

Motion to accept the minutes of April 27, 2021 as received by Councilwoman Cheatham, seconded by Councilman Lorenzo and approved on verbal vote. Councilwoman White abstained.

CORRESPONDENCE:

ROCKAWAY TOWNSHIP BOARD OF HEALTH - Peter wanted us to know, for those that don't know, Mega sites are now accepting walk ins for the COVID shots. They want you to call if possible, but you don't have to. You can just walk in. Hours are from 8 am until 3 pm.

CURRENT COVID CASES - We now have 247 confirmed cases in Victory Gardens. Last report we had 235 so we are up 12 more cases. 123 male, 124 female. The Mayor asked if Peter said anything about getting vaccines through Rockaway Township? Right now they haven't received any. We are on the list to have a clinic here if and when they get vaccines. At that time they will also do our shut ins.

We have talked about this on and off for some time. We went out to bid and he reviews everything. There is no breakdown on the voucher for tonight. It just deals with solid waste. Attorneys are suppose to put down how much time they spend on certain items. I think he usually does.

Jim Janone - The Attorney usually does itemize his bills. Did the Attorney file the complaint regarding the Dover Board of Ed? I don't know. Council gave him permission to do so. He is out of the office this week. The public assets that you are donating does state law permit that? I believe so. We have done it in the past. This is a donation. Normally things ar auctioned. Yes, we have auctioned in the past. Is Coolidge Avenue still being done under a grant? Yes. We have bid openings for the project for May 27. Franklin Road is suppose to be milled and paved by Friday. I haven't heard when they would complete. When you do the new garbage bids, this is something that Council will discuss before hand? I hope so. We have a few things they need to talk about. You could limit the amount of bags people put out. Yes, the Clerk said along with that we have discussed making residents pay for large items, for appliances. There are people that put out a lot of garbage.
