We have a few tools here that are Eddies and he will be taking them when he leaves. We need a tool cabinet. It is on sale at a cost of \$579.00. We have tools all over the place.

Councilwoman Garica Montes - This year we hired a CFO, and a part time Clerk. All is going ok. I would like to thank Councilwoman Hedgepath for her work on the Christmas party and the senior party.

Motion to accept all reports by Councilwoman Montes, seconded by Councilwoman Hedgpeath and approved on verbal vote. None opposed.

NEW BUSINESS:

Transfer Resolution - I gave everyone a copy. I received this from Joe this morning.

Councilwoman Hedgepath said she is voting no on this. The reason being, when I asked what was in the budget for recreation before the senior party, I don't think he gave Letty and accurate number. I was told there wasn't that much money in recreation so I don't understand how he can take money from recreation and put into another line item. This should have been given to us earlier and we could have had him tell us what was going on.

The Clerk said if this doesn't get passed tonight then we will be short in the other line items where he wanted to do the transfers.

Council said to put it on hold. Okay.

Jim Janone - In regards to snow plowing who is this other person going to be? We have to find someone. We may not need anyone but if we do, we will find someone. HOw many seniors attended the senior party? About 10. How much was it? About \$200.00. I want to get some information on the vacant lot. Do you want a letter or an OPRA request? Do the OPRA. For the attorney, you can look at other towns ordinances and their procedures for the cannabis and see how they are doing their applications. Do you know about the lead inspector needed for the town? No, I haven't heard anything about it. Why is the voucher listing for the school being shown on the vouchers? It is always on the vouchers. The reason it is so high is because they were put on for the past several months and they have to be on. we still aren't paying them but we have the list the amount and cut a check. We are holding the checks. If we have 250 kids that are enrolled in Dover and some move out to we get a credit for those kids? No. The figures are based on what the enrollment is in October. Whether or not it goes up and down they base everything on the October numbers. Do we have a certified lead inspector in the town? No. I will have to talk to our Board of Health. 1,400 for the gas bill is very high. We are on the budget and that is what the amount is. We also heat the garage.

Motion to close the meeting to the public by Councilwoman Montes, seconded by Councilman Hale and approved on verbal vote. None opposed.

Motion to adjourn the meeting by Councilwoman Montes, seconded by Councilwoman Hedgepath and approved onverbal vote. None opposed.
