CANNABIS LICENING AND PROCEDURES CONTINUED: We can say that if the State approves it we will approve it. But, there still has to be a process by how we do it. I am open to suggestions as to how you want to do this.

Councilwoman Montes asked if we can ask other towns? The Attorney said that we are unique situation. The other towns have enough people to fill these requirements of a committee for this particular thing. Randolph and Dover and other surrounding towns did not allow cannabis.

The Mayor asked if we have to do something with the Federal Government No. Taxes go to the State. The Federal government is against this. Federal law says it is a dangerous drug.

The Clerk asked how we know how much business they are doing and how do we follow the money that is coming in to the operation. They report to

the State and we can have them to report to us also.

Councilman Lorenzo said that if they are paying in cash it is hard to track that. Yes, it is. We will never fully know how much they are making and what is being paid. The Attorney said they do it by how much cannabis is bought. They look at your inventory and tax you on that.

The Clerk said that when all this was coming around, it went before our planning board and the planning board said no, they did't want it in the town. It came before Council and Council approved it.

The Attorney said the planning board makes recommendations to the Council but htey can't approve it. In our town you have to come before the planning board for any type of business. This is to let them know who you are, hours of operations, employees, what the business does, etc. What do we do, because there is someone that wants to go into the mini mall across the street, what happens if they come in to the planning board and they deny them?

The Attorney said that is a good question and he doesn't have the answer for it. I don't know if it would be a planning board recommendation or if it would be an actual action taken by that board. The Attorney said the Planning BOard has the pwer to structure what the company needs to do. They can say it can't be within so many feet of a school, playground,

town hall, they can say the hours of operation, not enough parking spaces, etc.

The Clerk said if they go into the mini mall across the street and
the planning board says no because of the promimity to other stores, ventilation problems, etc. what happens? If it is something like that,

the Attorney said the planning boarad can deny it.

The Attorney said the planning baord needs to structure the ordinance and then give it to us sowe can add to it if we so choose. They also have to apply to the State. The Clerk said they did apply to the State and they were given the okay but they only have a certain amount

of time to secure a location otherwise they use their license.

The Clerk told the members of the planning board they will have to discuss this at their meeting next week to get hte ball rolling and figure out what

they want to do.

Councilman Lorenzo said that they want to go where other businesses are. There is a restaurant there and you have to understand the impact it may have on these other businesses.

We will see what we can find the Clerk said and forward what we find to the attorney for review.

# OLD BUSIENSS:

TRANSFER RESOLUTION - We aren't doing this tonight. I am waiting on Joe to give and explanation as to why we were doing the transfers. Until I get something from him, we aren't doing it.

- We already approved the trees being cut down. TREE ESTIMATES I couldn't tell the company they won the award because I was waiting on Joe to male sure we had money in the line item to get them taken down. He got back to me and told me to hold off. So, we can do them now because we arein a new year. I called the contractor and told them they can start. the panel was out. How long was this out for? Almost a month.
Several hours during the weekend. You just can't come once.
With the cannabis, the funds you get for that, where would it
go, the money they pay the town. I think it would be the regular
operating budget unless there has to be a dedicated fund.
If someone comes in with approvals from the State, and they
apply with us, how can planning board say no to them. There is
nothing in the land use. They have to give specific reasons as
to why they would deny. It was just a discussion that the
planning board had at a meeting and they said they didn't want it
in town but then Council did an ordinance saying it was okay.
If planning board denies something I think they can apply to
the Council. The Attorney said that is what has to be put in
an ordinance.
