They also get a food license for serving food. That is all we deal with. Dovers Capital Program for water main replacements/repairs. DFo we know when they will be doing that? We don't know right now. They did say they were going to start working on the water lines - that was about 2 years ago. They would update us when they were going to start. We haven't heard anything. They were going for grants and a lot of it depended on that.

The Attoreny said he had a few things before the meeting gets adjourned. As you know we are holding approximately \$600,000 from the Dover BOE. It is ourmoney and they are trying to get it. They want part of the money. We are waiting to hear from the court.

The State came out with updated information regarding the cannabis operations throughout the State. They amended the law and are now saying it is okay for pickup at curbside. The client has to notify the town that they want to do that. The Clerk said the town should have a say so on if they are going to allow this. The Attorney said it is a law already and he doesn't think the towns can do anything about it. The Attorney after much discussion said that he doesn't believe the towns have the right to change it.

The Attorney asked if anything was discussed regarding the fire department? The Clerk said no, not at this time. The Mayor and I are

meeting with Mayor Dodd on Thursday and once we talk to him we will bring it back to the Council at the next meeting.
